<b>C</b>	<b>Accessory Building(s):</b> Storage shed, vehicular enclosure, workshop, tool shed, green house, pool house, pool pump/filter house HHC VII-4, HHC X-2, 3, ARCG) <b>RCCD permit also required</b>
<b>D</b>	<b>Landscape:</b> Clear existing, add new defined areas, trees, shrubs, gardening area, add hardscape, rocks, concrete, pavers, berms, edging, retaining walls, change drainage system or pattern (HHC VII-4, HHC VIII-21, HHC X-5, ARCG) <b>RCCD permit also required for retaining walls exceeding 3 ft</b>
<b>E</b>	<b>Misc./Ornamental:</b> Flagpole(s), shade(s), awnings, sidewalks and pathways, shutters, house ornamental decorations, fountains, lights, etc. HHC VII-4, HHC VIII-17,18, 19, HHC X-12, ARCG)
<b>F</b>	<b>Fences:</b> Add new, change height, relocate section(s), change color, permanently remove section(s), swimming pool enclosure (HHC VII-4, HHC X-1, 8, ARCG)
<b>G</b>	<b>Swimming Pools:</b> Pool, spa, hot tub, decorative fountain, or pond. <b>RCCD permit also required</b>

<b>B</b>	<b>Accessory Structure(s):</b> (1) Submit basic lot plan showing location relative to house and within lot setbacks (2) Standard construction top, front, and side elevation drawing with size measurements (width, depth, height) (Note: a picture or facsimile with measurements may suffice) (3) Materials to be used (kit or manual construction) (4) Colors to be used
<b>C</b>	<b>Accessory Building(s):</b> (1) Submit basic lot plan showing location of structure relative to house (2) Include two (2) sets of construction plans or drawings (3) List materials to be used (4) List of colors used (5) Basic lot drainage plan
<b>D</b>	<b>Landscape:</b> (1) Submit basic lot plan showing affected area location relative to house and within prescribed setbacks (2) Basic lot drainage plan (3) List types of plants to be included (4) List hardscape materials
<b>E</b>	<b>Misc./Ornamental:</b> (1) Simple description of changes to be made and affected portion of house (2) Proposed colors (3) Materials to be used
<b>F</b>	<b>Fences:</b> (1) Submit basic lot plan showing location relative to house (2) List colors to be used
<b>G</b>	<b>Pools:</b> (1) Submit basic lot plan showing location relative to house and within setbacks. (2) Include two (2) sets of construction plans or drawings (3) List materials to be used (4) List of colors used (5) Basic lot drainage plan (6) Cleanout discharge runoff plan
