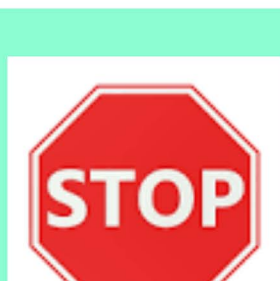
**ARCITECTUAL
